Call Durations are specified in this document as a charge of BDS\$ per 60s. However, pursuant to the terms of the Service Descriptions, Calls will be measured to an accuracy of 1/10th of a second, and the Charges will be the sum of the month's measurements rounded to the nearest minute. Further detail of the billing process and procedures can be found in the Joint Working Manual.
