Comments on Consolidated RIO

Dear Ms. Sealey,

We have examined the draft Consolidated RIO prepared by LIME. We believe this document should reflect current Government policy and past rulings by the FTC, and provide for the competitive operation of all licensed carriers in a fully liberalized telecommunications environment.

Blue wishes to highlight several areas:

(1) Service Descriptions

We believe the draft is deficient as there is no Service Description for Outgoing International Call Termination from PSTN and PLMN. As two-stage dialing and equal access have both been mandated by Government, these sections must be added in order for the draft to cover all available services.

In addition, Blue has been authorized by the Telecommunications Unit to obtain a CIC code and has been issued 1011258 on March 6, 2008 by NAMPA. We therefore require that CIC code access be addressed in the draft.

(2) Service Descriptions – Sections 1.5.3, 2.5.3, 3.5.2 and 4.5.3

There is an annotation next to Call Duration Charges which refers to an "Access Deficit Charge". The Access Deficit Charge was specifically prohibited by the FTC in its ruling of October 28, 2003 and should be removed from the draft.

(3) Service Descriptions – Sections 3.2.2

The draft states "The Service Taker will not convey Incoming International PSTN Termination Calls pursuant to this Service Description addressed from number ranges within countries with whom the Service Taker does not have a correspondent relationship."

RIO III clarified that calls may be conveyed through another correspondent relationship which may specifically allow the conveyance of calls from that Third Party International Telecom Provider. This has been left out and should be reinstated.

(4) Tariff Schedule - Schedule 6, Part 2

All of the proposed costs for interconnection are based on historic costs estimated in 2003. Cost-based services have been mandated by the FTC, specifically requiring LIME to break down component costs to their lowest common denominator. Blue believes that an examination of current costs in light of ever improving network efficiencies and falling equipment prices will result in significant downward adjustment in the interconnection components specified in the Consolidated RIO.

Specifically, call setup charges were historically based on stepping and crossbar switching technologies which no longer exist in LIME's network. Modern SS7 and IP networks have call setup costs so negligible as to have been eliminated in other jurisdictions, including Jamaica in its RIO 5A1. We therefore recommend the call setup charge of \$0.0402 to PSTN and \$0.031 to PLMN be eliminated.

Similarly, transit charges have a negligible cost in modern networks, as evidenced by a recent decision in Trinidad to reduce transit charges to less than US \$0.003. We therefore recommend the transit charge to third party PSTN and PLMN of \$0.011 also be examined.

Blue welcomes the opportunity to provide comment on the draft Consolidated RIO and to expand on its views during the upcoming public discussions.
